SGS HONG KONG DEVELOPS NEW TESTING CAPABILITY FOR SWIMMING GOGGLES

Swimming is one of the most popular sports in the world. It is a healthy activity that you can continue for a lifetime and a low-impact activity that has many physical and mental health benefits

Swimming goggles are an essential part of your swimming gear. The advantages of wearing swimming goggles during prolonged swimming activity to reduce or prevent eye irritation, to improve vision through the water.

SGS Hong Kong is delighted to announce a NEW Testing Service for swimming goggles per BS ISO 18527-3: 2020, which specifies requirements and test methods for eyewear intended for surface swimming. It was published in January 2021 and has superseded the previous standard of swimming goggles (BS 5883:1996).

BS ISO 18527-3 is applicable to surface swimming goggles with:

- a) non-prescription nominally plano or afocal lenses,
- b) non-prescription mass-produced corrective lenses, and
- c) prescription lenses



The newly published standard defines the general requirements, optical requirements, mechanical strength requirement, other requirements, and labelling/ marking requirements.

- Instructions for care and cleaning shall be provided prior to testing, as submitted sample will be cleaned only accordingly to the cleaning and/ or disinfection procedures of instruction provided
- Headform 1-M (with 64mm interpupillary distance) would be used for those test methods where headform is required
- Any claim specification of the product would make requirements marked as optional become mandatory
