IAS FURTHER EXTENDS SGS ACCREDITATION **SCOPE FOR MEDICAL MASK TESTING**

Despite signs that the COVID-19 pandemic begins to recede, wearing mask has become a new norm around the world. Since the pandemic started, many local manufacturers started to establish their mask production lines to ease the supply shortage.

With the introduction of our mask testing services in Feb 2020, SGS Hong Kong had continuously upgraded its services to cope with the everchanging industry.

With previous accreditations from <u>HOKLAS</u> & IAS, FDA's recognition as an official 510(k) Third-Party reviewer and the development of Viral Filtration Efficiency (VFE) capability earlier this year, our scope of accreditation continues to broaden.



In August 2021, SGS Hong Kong had further extended its accreditation scope under International Accreditation Service (IAS) for mask testing services, becoming the first testing lab, and the only to-date, to be accredited for VFE and Biodegradation testing for medical face mask in Hong Kong.
